## CSPS Scoring Key

The California School Parent Survey (CSPS), along with its companion student and staff surveys-the California Healthy Kids Survey (CHKS) and the California School Parent Survey (CSPS)—form the California Department of Education's California School Climate, Health, and Learning Surveys (CaISCHLS) System. CalSCHLS is the largest, most comprehensive effort in the nation to regularly assess students, staff, and parents at the local level to provide key data on school climate and safety, learning supports and barriers, and stakeholder engagement, as well as youth development, health, and well-being.

The CSPS assesses parent perceptions about the school's learning environment, school climate, student supports, and parent outreach and involvement efforts. Described below is the scoring key for scales in the Core Module (Parent CSPS).

This scoring key documents how scores for the scales are computed. Scale scores are calculated by averaging the percentage of respondents who report select response categories on the survey questions that comprise each scale. For example, a value of 50 on the "Promotion of Parental Involvement" scale means that on average, students report "Strongly agree" on three of the six "Promotion of Parental Involvement" survey questions.

Survey questions, select response categories used to calculate the scale, and the required number of items for each scale are listed in the following tables. Response options of the survey questions and the corresponding numeric codes are listed in the footnotes.
